3. Initiated/rescued/enhanced/saved a midwifery service and/or education program

5. Furthered the legislative agenda for full scope midwifery practice

APPLICATION DEADLINE: November 10, 2017

ELIGIBILITY REQUIREMENTS:

- Be a CNM or CM certified for at least ten (10) years
- Be a member of the American College of Nurse-Midwives (ACNM).
- Has not been a recipient of the Hattie Hemschemeyer Award

- Be a member the American College of Nurse-Midwives.
