# Physiologic Labor Expression and Provider Response, 2023

The way individuals express the sensations of labor and birth has not been well documented in the literature, and yet it is key for providers to understand this expression to best support laboring individuals. The purpose of this study was to better understand how laboring individuals expressed the sensations of labor and how they perceived the support of the team around them. The objective was to describe the ways people managed the sensations of labor and birth and how they interacted with the people around them. This study was mixed methods, including a survey for demographic information and birth satisfaction ratings and a qualitative interview. Recruitment was completed primarily through mailed flyers to people who had experienced birth without an epidural. It was completed at a rural New England academic medical center which is the site of approximately 1700 births per year. Seventeen qualitative interviews were completed using a framework of descriptive phenomenology. Participants expressed the need for autonomy to do what is instinctual in labor.

Other helpful tools were primal low moaning sounds, gripping with their hands, and rocking movements. Participants described an inward focus in which they often repeated reassuring phrases to get them through. In addition, participants felt it was important for the provider team to read the room well, listen to and believe the person in labor, and avoid interruptions. The study found that coping was very internal and did not find that people were using sound or movement to communicate outwardly with their team. This study found that people experiencing physiologic birth needed autonomy to follow their instinct. They used low moaning sounds and used their bodies to rock and their hands to grip. In addition, they identified relying on internal reassurance. This knowledge has the possibility of influencing the way people in labor are cared for in birth settings. This research should be replicated in other populations for generalizability.

# State Boards of Midwifery, 2007

Abstract: A policy feasibility study of creating state-level boards of midwifery as a regulatory structure. It explores the history of how the current regulatory system developed, as well as the factors that would affect the creation of a board of midwifery. This is an important analysis because it affects how midwives are regulated and, thus, their scope of practice. That scope, in turn, has a trickle-down effect on the availability of midwives to individual healthcare consumers. The method employed by this study is a multifaceted analysis of the literature combined with the solicitation of information from key people who are involved in policy formation. This paper finds that there are many legislative options that need to be analyzed on a state-by-state basis. Each state has a distinctive regulatory environment which will be uniquely impacted by a board of midwifery.
